

Los Angeles County Chapter

The ACEC CA Los Angeles County Chapter (ACEC LA) has been successful in promoting the industry and enhancing public awareness of services. Key achievements this year include hiring a new Executive Director with industry knowledge and continued public awareness through a newly developeed website. We also continue to work with our agency liaison committees with a a growing number of members and member firms.

PROMOTING INDUSTRY LOCALLY

Monthly Luncheons/Webinars - Our chapter has a thriving monthly luncheon program that brings owners together with the consulting engineering community. Owners present their upcoming capital improvement and expansion programs and contracting opportunities. This past year, we hosted ten monthly luncheon events featuring speakers from owner organizations such as City of Los Angeles, Ports of Long Beach & Los Angeles, California High Speed Rail, LAWA, Caltrans District 7, Metro Regional Rail, Virigin Hyperloop, Metro Program Management Group, CalSTA, and Metro Innovation Group.

Golf Tournament - In March, ACEC LA had to cancel our annual charity golf tournament at the Old Ranch Country Club in Seal Beach due to the pandemic. We were able to reschedule our tournament to May 2021 and 22 of the 25 foursomes who were to participate agreed to transfer their funds to 2021 and 9 out of 11 sponsors who were to participate agreed to transfer their funds to 2021. Therefore, we were still able to give out \$20,000 in scholarships in 2020 and 2021.

ENHANCED PUBLIC AWARENESS

Student Outreach

Committed to offering opportunities to the next generation of engineers and surveyors, ACEC LA promoted student education through our provision of scholarships and participation in National Engineers Week.

National Engineers Week - With the help of our member firms, ACEC Los Angeles County Chapter in partnership with Los Angeles County and Caltrans had 23 engineers present to 15 schools throughout Los Angeles County!

Scholarships - Established in 2005, the scholarship fund rewards qualified undergraduate and graduate engineering students attending Los Angeles County colleges and universities. Recipients must demonstrate a high level of academic achievement from an accredited engineering program; participate in professional associations, programs and internships directly related to engineering; and provide recommendations and endorsements from faculty. This

year, we awarded six scholarships totaling \$20,000. The scholarship amounts ranged from \$2,000 to \$5,000. Please visit our new website at https://acec-la.org/ to view the videos of each of our scholarship receipients.

Public Relations/ Website

ACEC LA maintains positive public relations with our membership, the consultant community and owner agencies in the Los Angeles County area by providing opportunities for networking, professional development and relationship-building. We developed a brand new website earlier this year and unveiled it in April 2020. We have received many positive reviews from our members and others who visit the site. Our Social Media Committee's social media presence includes public information and positive outreach via pages on three platforms (LinkedIn, Twitter and Facebook). Today, our dedicated LinkedIn account includes 121 followers, Twitter account includes 163 followers, and 70 followers of our Facebook page.

Recruitment Efforts

With outstanding membership growth and participation, our chapter's recruiting efforts include welcoming non-members at monthly luncheons and retaining members through successful programming. Our success is evidenced by event attendance growth from 30 attendees per event in 2005 to an average of more than 80 attendees per event this year even with the pandemic. We have been able to move our programs to webinars which have had higher attendance than even our in person luncheons.

Special Events

Annual Banquet - This was the event that was hardest hit by the pandemic. Originally scheduled to be in late April 2020 we had to cancel the event completely as an in person event of over 300 attendees and six awardees. We worked with the committee to figure out another way to give out the awards late this year. The committee is currently working with the four main awardees of ENGINEERING ACHIEVEMENT: AECOM HUNT/Turner Joint Venture & City of Inglewood for the LA Rams Chargers SoFi Stadium; CLIENT OF THE YEAR: Los Angeles County Metropolitan Transportation Authority Program Management Group; INNOVATOR OF THE YEAR: City and Port of Long Beach P3 City Hall/Port Headquarters Complex Project; and CHAMPION OF SMALL BUSINESS: Los Angeles World Airports (LAWA) to put on a virtual awards cocktail hour in late January 2021. We will be delivering the awards to each of the award recepients and will be raising a toast and presesnting the awards virtually. We look forward to this event in 2021.

IMPROVING BUSINESS PRACTICES

Small Business Committee

ACEC LA's Small Business Committee helps our small businesses maximize the benefits of ACEC membership. This year the committee held committee meetings that discussed and informed our small businesses on current trends, important issues that architecture and engineering firms need to address in the development of their financial systems, payment provisions and insurance provisions, as well as actions that firms can take to enhance the quality of company operations and financial stability.

Qualifications-Based Selection (QBS) Committee

The QBS committee continued to build on the momentum created by the ACEC Californa initiative in early 2018, with a focus on how QBS laws should be applied at the local level and how QBS benefits our members and their clients. The QBS Committee met mulitple times and at the end of this year, in July 2020, the committee developed a joint QBS webinar panel with APWA So Cal Chapter that included over 200 attendees and 35 Southern California agencies.

Liaison Committees

ACEC LA's liaison committees provide a forum for members and owners to discuss current and future design and construction programs as well as other industry issues and concerns. Highlights from our liaison committees include:

Caltrans District 7 – This committee's meetings are held every other month and attended by large and small member firms. Over this last year attendance at these meetings has increased from an average of 25 to over 50 attendees per meeting. Topics this year included: ADA Updates, Design Standard Decision Document (DSDD), Connected and Automated Vehicles (C/AV), Caltrans Environmental Process for Consultants, Caltrans Complete Streets, COVID-19 Updates, AE Interview Attendee Certification, and Caltrans Asset Management.

Metro – Our most popular liaison committee, presentations are provided by executive directors and senior staff representing Metro departments including highways, transit planning, facilities engineering and procurement. Metro has also partnered with ACEC LA on procurement practices, new policies and board agenda items through active support of a procurement subcommittee focused solely on the discussion of ways to streamline their proposal process.

State and National Participation

Our chapter members are active in ACEC state and national efforts that enhance our industry. Our chapter has 26 members serving on ACEC California committees, with five of them on the board of directors and one serving on the executive committee. We also have chapter members involved at the national level.

Legislative Activities

Conflict of Interest legislation came into the forefront of the ACEC 2019 agenda. Assembly Member Sharon Quirk-Silva was the author that planned to bring the legislation to the floor. However, a fringe element of the building trades coalition opposed the bill and with the help of a news article from Cal Matters the legislation died and never made it to the floor for a vote in the 2019 session.

ACEC LA President Jesse Urquidi strategized with ACEC Gov Affairs Director Tyler Munzing as to what was the best way to address the issue and start conversations for the a new author and possibly "educate" key legislators for the 2020 legislative session. In December 2019, ACEC CA had an extra ticket to the Moderate Dem Caucus dinner in Carlsbad. Tyler Munzing invited Jesse Urquidi to attend and at that event Jesse and Tyler connected with several assembly members and senators including: Assm Blanca Rubio, Assm Rudy Salas, Assm Patrick O'Donnell, Assm Mike Gipson and Senator Steve Bradford.

In January 2020, Jesse also traveled to Sacramento and setup meetings for ACEC along with Tyler Munzing. The objective was to get the ACEC position on conflict-of-interest legislation. Jesse met with CA State Senator Lena Gonzalez, Assembly Member Patrick O'Donnell, CA Contact cities Exec Director, Marcel Rodarte, Senator Steven Bradford, Assemblywoman Blanca Rubio and Senator Susan Rubio

The trip was a success in that the ACEC team was able to educate and provide outreach to the organizations and legislative offices that we know would take a look a this legislation for future consideration.

ADJUSTMENTS DUE TO THE PANDEMIC

Our chapter like others had to make adjustments starting in March of this year due to the pandemic. We had to reschedule our two big events, our golf tournment and awards banquet. But we did not let that stop us from awarding \$20,000 in student scholarships this year. We moved to virtual programs or webinars in May and started meeting with our liaison groups virtually as well. We were able to reach more members during this time with our virtual programs and even increased participation across the board. We implemented networking into our virtual meetings which helped our members not only stay connected but discuss important topics during this challenging time. Through our continued commuications both on our website and social media channels we were able to get information to our members in a timely manner. We are continuing to look at new ways to engage our members and look forward to when we can see each other in person again.



ACEC LA CHAPTER CHAMPION

I have nominated Jeff Walker as the LA Chapter Champion for the 2019-2020 year. Jeff has been an LA Chapter board member since 2012 and recently completed his service on the State Executive Committee and as National Director. Understanding the issues spearheaded by the ACEC state organization, communicating them to the local chapters, and taking the local chapters recommendations to the state board is a major duty of the State Directors. Though not a State Director for the LA Chapter, Jeff has used his role on the State Executive Committee be a strong champion for the LA County Chapter.

In his role on the State Executive Committee, Jeff has promoted the Civil Engineering profession, providing direct input on the bills that had a direct impact on consulting firms, and met with local and state officials to present pros and cons of the bills focusing on the civil engineering profession. As an active member of the Legislative Committees and the State PAC, Jeff has provided valuable input in promoting many challenging issues facing our profession including contracting out, qualifications based selection, prevailing wage, and fair contracting practices.

Jeff is a true believer of the ACEC mission to promote civil engineering consulting firms to make their contribution to make the United States of America in general and the state of California in particular a better and safer place to live. His "Can Do Attitude" and expressing it in professional meetings with other colleagues has resulted the growth in membership once other firms understood the benefit they would get by joining ACEC.
